[5] **ORDERS** the Debtor not to sell or otherwise dispose of any of the Remaining Inventory before December 17, 2018 at 21h00;

[6] **POSPONES** to December 17, 2018 at 9h30, the parties representations on the *Motion for the Extension of the Delay to File a Proposal* and the *Bene Esse Motion to Lift the Stay of Proceedings and for Additional Relief*.
