

NOTE:

Note 1: On October 10, 2014, 161617 Canada Inc. ("Debtor") filed a Notice of Intention to Make a Proposal to its creditors and Richter Advisory Group Inc. was appointed Trustee.

On November 7, 2014, the Court granted a first extension of delay of 45 days for the filing of a Proposal to December 22, 2014, in order to allow Debtor additional time to complete the implementation of its restructuring plan.

On December 22, 2014, the Debtor filed a Proposal in accordance with the Bankruptcy and Insolvency Act.

A Proposal was submitted by the Debtor at the meeting of creditors on January 12, 2015 and was duly accepted by the required majority of creditors. The said Proposal was ratified by the Court on January 26, 2015.

The dividends were distributed in four installments in the aggregated amount of \$180,000.00 on the following dates to the creditors:

- 1) February 24, 2015;
- 2) February 24, 2016;
- 3) February 24, 2017;
- 4) February 24, 2018.

On May 11, 2018, the Trustee issued the Certificate of Full Performance of the Proposal.
