NOTES :

- Note 1 :** On June 24, 2014, K.F.S. Limited, 2726556 Canada Inc., and Nathar Limited (collectively as the "**Debtors**" or the "**Companies**") filed a Notice of Intention to Make a Proposal ("**NOI**") pursuant to Subsection 50.4(1) of the Bankruptcy and Insolvency Act (Canada).
- Note 2 :** On July 22, 2014, September 8, 2014 and October 23, 2014, the Court granted extensions of time for the filing of a Proposal through to November 7, 2014 in order to allow the Debtors to obtain the administrative consolidation of the NOI proceedings and to finalize the terms of a viable proposal that will maximize the dividends to be paid to the Debtor's Ordinary Unsecured Creditors.
- Note 3 :** Subsequently, on October 27, 2014, the Court granted that the NOI proceedings of the Debtors be consolidated and that, as result thereof, only one common Proposal be filed.
- Note 4 :** On October 31, 2014, the Debtors filed a Proposal in accordance with the Bankruptcy and Insolvency Act.
- Note 5 :** The meeting of creditors on November 21, 2014 was duly accepted by the required majority of creditors. The said Proposal was ratified by the Ontario Superior Court of Justice (Commercial List) on December 8, 2014.
- Note 6 :** On April 7, 2016, the Trustee issued the Certificate of Full Performance of the Proposal.


