**SECOND REPORT OF THE TRUSTEE  
ON THE STATE OF PETITIONER'S BUSINESS AND FINANCIAL AFFAIRS**

---

Richter Advisory Group Inc. (“**Richter**” or the “**Proposal Trustee**”), in its capacity as trustee with respect to the Notice of Intention to Make a Proposal (“**NOI**”) filed by 2964-3277 Quebec Inc., doing business as Carpet Art Deco (the “**Debtor**” or the “**Company**”), an insolvent person, does hereby report to the Court the following:

**INTRODUCTION**

1. On November 29, 2018, the Debtor filed the NOI in accordance with Section 50.4(1) of the *Bankruptcy and Insolvency Act*, R.S. C. 1985, c. B.-3, as amended (the “**BIA**”), and Richter was appointed as Proposal Trustee under the NOI. A copy of the Certificate of Filing issued by the Superintendent of Bankruptcy is annexed as Exhibit “A” to the First Report of the Trustee dated December 12, 2018 (“**First Report**”).
  
2. On December 5, 2018, documents were sent by regular mail to all creditors of the Debtor, as identified by it, which included a copy of the Debtor’s NOI, which is annexed as Exhibit “B” to the First Report.

3. On December 6, 2018, the Debtor filed with the Official Receiver a Statement of Projected Cash Flow (“**Projections**”) together with his report pursuant to Section 50.4(2)(c) of the Act, covering the period from November 29, 2018, to January 11, 2019, which included the major assumptions used in the preparation of the Projections. Concurrently therewith, the Proposal Trustee filed its Report on the reasonableness of the Projections in accordance with Section 50.4(2)(b) of the Act, all of which is annexed as Exhibit “C” to the First Report.
4. On December 10, 2018 the Debtor filed a motion entitled *Motion for the Issuance of an Order for an Administrative Charge, a Directors and Officers Charge, a Key Employee Incentive Program and Other Remedies* (the “**Charge and KEIP Motion**”). The Charge and KEIP Motion was granted on December 13, 2018.
5. On December 11, 2018, Oriental Weavers International SAE (“**OW**”) filed a motion entitled *De Bene Esse Motion to Lift the Stay of Proceedings and for Additional Relief* (the “**OW Motion**”). The hearing for the OW Motion commenced on December 13, 2018. A judgment was issued on consent with respect to part of the relief sought in the OW Motion on December 13, 2018 (“**OW Judgment**”), however the debate on the merits was postponed to a further hearing on December 17, 2018.
6. On December 12, 2018, the Debtor filed a motion entitled *Motion for the Extension of the Delay to File a Proposal* (the “**Stay Extension Motion**”). The Stay Extension Motion was scheduled for hearing on December 13, 2018, however it has also been postponed to December 17, 2018.
7. In order to monitor the affairs and finances of the Debtor, the Proposal Trustee has been provided with access to the books, records and other important documents of the Debtor.

## PURPOSE OF THIS REPORT

8. The purpose of this Second Report is to fulfill the Trustee’s undertaking, as set forth in the OW Judgment, pursuant to which the Trustee is to:

“....provide OW, no later than 21h00 on December 14, 2018, with a summary of the cost value of any of these goods sold and delivered by OW pursuant to the invoices filed as Exhibit P-1 that are currently located in the warehouses of the Debtor according to the books and records of the Debtor (**Remaining Inventory**) and to perform not less than ten (10) spot checks of the Remaining Inventory listed in the Debtor’s books and records and **ORDERS** the Trustee to respect its undertaking.”

## TERMS OF REFERENCE

9. Unless otherwise noted, all monetary amounts contained in this First Report herein are expressed in Canadian dollars.
10. In preparing this Second Report, the Proposal Trustee has relied upon certain unaudited financial information prepared by the Debtor's representatives, the Debtor's books and records, and discussions with the Debtor's representatives and legal counsel (the "**Information**").
11. Except as otherwise described in this Second Report, the Proposal Trustee has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Generally Accepted Assurance Standards ("**GAAS**") pursuant to the Chartered Professional Accountant of Canada Handbook and, as such, the Proposal Trustee expresses no opinion or other form of assurance contemplated under GAAS in respect of the Information.

## COST VALUE OF THE REMAINING INVENTORY

12. In preparing this Second Report, the Proposal Trustee principally relied on the Information produced by the Company's information systems and worked with the following individuals at the Company to understand the systems and obtain the Information summarized herein:
  - a) Michel Melki – Vice-President, Operations;
  - b) Steve Roussos – CFO;
  - c) Tania Comisso – Business Analyst;
  - d) Mikael Avanesov – Supply Chain Analyst; and
  - e) Various warehouse personnel who assisted with the performance of inventory spot checks.
13. Using the list of outstanding invoices as provided by OW (which list totaled US\$2,576,770.05), The Company produced a report of inventory on hand which contains approximately 43,000 line items (the "**IOH Report**"). In order to understand how the Proposal Trustee verified the contents of the IOH Report, it is necessary to understand how the values in that report were generated.
14. The IOH Report was prepared by relying on the "Batch Number", which is a number assigned to each item number" (an "**Item Number**") in the original packing list that is provided by suppliers. Each Batch Number is sequential and was created to enable the Company to properly track inventory usage for customs duty purposes, including to allow the Company to track which inventory is eligible for duty drawback.

15. In the ordinary course of business, using the Batch Number, the Company reduces inventory on hand on a first in, first out ("FIFO") basis, by warehouse. In other words, when inventory is shipped to a customer, the oldest inventory (based on the date of receipt by the Company) of a particular Item Number (from whichever warehouse the inventory is located in) will be reduced.
16. The Proposal Trustee selected five (5) Item Numbers to test the FIFO methodology and based on the samples reviewed, the inventory system appears to function as described by the Company.
17. Based on the Company's system and the contents of the IOH Report, the following inventory included in the invoices listed as Exhibit P-1 to the OW Motion is presently being stored at the Company's warehouses:

18. Annexed as **Exhibit "1"** is a listing of all the unpaid invoices claimed by OW which includes the invoice date and the cost value of the inventory, as reconciled to the books and records of the Company.
19. Annexed as **Exhibit "2"** is a listing of inventory claimed by OW and held in the Company's warehouses as at December 14, 2018, which totals US\$579,002. We note that for certain of the Remaining Inventory, the actual quantity on hand as of December 14, 2018 does exceed the quantity included in the column "remaining on hand". Based on discussions with the Company and our limited testing, the reason for this is that certain items were purchased on multiple occasions from OW, or possibly from other suppliers, and these items may have already been paid for by letter of guarantee.
20. The Proposal Trustee understands that an entity by the name of Coface has provided credit insurance to OW on some of these shipments. The review of the unpaid invoices included as Exhibit 1 to this Second Report identifies which invoices contain a reference to Coface. At a minimum, it would appear that approximately US\$1.6 million (64%) in value of the outstanding invoices may be insured by Coface. As to the remaining invoices, the Company believes that certain of these may also be insured by Coface, although the Proposal Trustee has been unable to verify this at the present time.

## **INVENTORY SPOT CHECKS**

21. The Trustee conducted ten (10) spot checks of the OW inventory as reflected in **Exhibit “3”**, in order to test the accuracy and completeness of the inventory quantities as reflected in the Company's system. Of the ten (10) items test counted (which include a mix of items treated as Remaining Inventory and other inventory purchased from OW), we comment as follows:
- a) four test counts revealed very minor differences;
  - b) three test counts reflected differences attributed to timing - orders were cancelled due to the OW Judgment and the inventory was counted in the warehouse, however, the company records were not yet updated to reflect the order cancellations;
  - c) three test counts require further analysis which could not be completed by the time of the issuance of this Second Report.

## **CONCLUSION**

22. The Proposal Trustee was necessarily limited in the tasks it could perform in light of the time constraints associated with the production of this Second Report. The Proposal Trustee nevertheless remains available to assist the Court and all interested parties in connection with this matter.
