To the Creditors of Fluid Brands Inc., 11041037 Canada Inc. and 11041045 Canada Inc.

- On October 25, 2018, Fluid Brands Inc. ("Fluid"), 11041037 Canada Inc., (dba Bombay) ("1037") and 11041045 Canada Inc. (dba Bowring) ("1045", and together with Fluid and 1037, the "Companies") each filed a Notice of Intention to Make a Proposal ("NOI") pursuant to section 50.4(1) of the *Bankruptcy and Insolvency Act* (Canada) (the "BIA"). The Companies each failed to file a proposal within the prescribed time period (or any extension thereof) following the filing of the NOIs and, as a result, the Companies were each deemed to have made an assignment in bankruptcy on January 9, 2019.
- 2. The undersigned, Richter Advisory Group Inc., was appointed as trustee of each of the bankrupt estates (the **"Trustee"**) by the Official Receiver, subject to affirmation by the creditors of the Trustee's appointment or substitution of another trustee by the creditors.
