**FIRST REPORT OF THE TRUSTEE
ON THE STATE OF PETITIONER'S BUSINESS AND FINANCIAL AFFAIRS**

Richter Advisory Group Inc. ("**Richter**" or the "**Proposal Trustee**"), in its capacity as trustee with respect to the Notice of Intention to Make a Proposal ("**NOI**") filed by 8738971 Canada Inc., doing business as Pazazz Printing Inc. / Imprimerie Pazazz Inc. (the "**Debtor**" or the "**Company**"), an insolvent person, does hereby report to the Court the following:

INTRODUCTION

1. On January 14, 2019, the Debtor filed the NOI in accordance with Section 50.4(1) of the *Bankruptcy and Insolvency Act*, R.S. C. 1985, c. B.-3, as amended (the "**BIA**"), and Richter was appointed as Proposal Trustee under the NOI. A copy of the Certificate of Filing issued by the Superintendent of Bankruptcy is annexed hereto as **Exhibit "A"**.
2. On January 18, 2019, documents were sent by regular mail to all creditors of the Debtor, as identified by it, which included a copy of the Debtor's NOI, as annexed hereto as **Exhibit "B"**.

3. On January 23, 2019, the Debtor filed with the Official Receiver a Statement of Projected Cash Flow ("**Projections**") together with his report pursuant to Section 50.4(2)(c) of the Act, covering the period from January 14, 2019 to February 15, 2019, which included the major assumptions used in the preparation of the Projections. Concurrently therewith, the Proposal Trustee filed its Report on the reasonableness of the Projections in accordance with Section 50.4(2)(b) of the Act, all of which is annexed hereto as **Exhibit "C"**.
4. On January 24, 2019 the Debtor filed a motion entitled *Motion for the Authorization and Approval of Interim Financing, Certain Charges, A Sale and Solicitation Process and Other Relief* (the "**DIP, SSP and Extension Motion**"). The DIP, SSP and Extension Motion has been scheduled for hearing on January 29, 2019.
5. In order to monitor the affairs and finances of the Debtor, the Proposal Trustee has been provided with access to the books, records and other important documents of the Debtor.

PURPOSE OF THIS REPORT

6. The purpose of this First Report is to provide this Court with information pertaining to:
 - a) A concise summary regarding the background and operations of the Debtor, its creditors and recent efforts undertaken to stabilize the Debtor's business operations;
 - b) The DIP Financing;
 - c) The Administration Charge;
 - d) The Sale and Solicitation Process;
 - e) The Debtor's statement of projected cash flow for the period from January 14, 2019 to February 15, 2019;
 - f) The Debtor's request for an extension of the statutory delay to file a proposal (the "**Proposal Period**") to March 13, 2019; and
 - g) The Proposal Trustee's recommendations that this Court make orders, as requested by the Debtor:
 - Approving the DIP charge;
 - Approving the Administration Charge;
 - Approving the Sale and Solicitation Process; and
 - Approving the extension of the Proposal Period to March 13, 2019.

TERMS OF REFERENCE

7. Unless otherwise noted, all monetary amounts contained in this First Report herein are expressed in Canadian dollars.
8. In preparing this First Report, the Proposal Trustee has relied upon certain unaudited financial information prepared by the Debtor's representatives, the Debtor's books and records, and discussions with the Debtor's representatives and legal counsel (the "**Information**").
9. Except as otherwise described in this First Report, the Proposal Trustee has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Generally Accepted Assurance Standards ("**GAAS**") pursuant to the Chartered Professional Accountant of Canada Handbook and, as such, the Proposal Trustee expresses no opinion or other form of assurance contemplated under GAAS in respect of the Information.
10. Future oriented financial information relied upon in this First Report is based on the Debtor's representatives' assumptions regarding future events; actual results achieved may vary from the Information presented even if the hypothetical assumptions occur and these variations may be material. Accordingly, the Proposal Trustee expresses no assurance as to whether projections will be achieved.

GENERAL BACKGROUND INFORMATION OF THE DEBTOR

11. The Company provides printing solutions and distribution of all visual and printed communications for commercial, industrial, and retail applications including packaging, signage and large format printing as well as graphic design, direct marketing, fulfillment and logistics services. The Company's customers are located primarily in Quebec, Ontario and the USA.
12. The Company operates in Montreal in leased premises from a third party.
13. At the time of the filing, the Debtor had approximately 50 full-time employees. Employee wages and remittance of deductions at source were current at the time of the filing.
14. The Debtor reported a net loss before taxes of approximately \$0.6 million for the year ended March 31, 2018 and \$0.8 million for the eight months ended November 30, 2018. The Debtor has attributed its significant operating losses to a multitude of factors including:
 - a) Overall reduced demand for print advertising and mailing and the loss of certain key contracts;
and

- b) Fixed overhead that is not aligned with current revenue levels, in particular, the leased head office/production facility that is too large and too expensive and certain expensive and unnecessary equipment leases.
15. Notwithstanding the Debtor's attempts to implement certain cost-reduction measures in the past twelve (12) months, the losses continued, and the financial situation deteriorated rendering the Company insolvent.
16. As a result of the financial difficulties the Debtor's secured lender, on January 9, 2019, the Toronto Dominion Bank ("**TD Bank**"), issued a notice pursuant to Section 244 of the BIA to enforce its security.
17. It was subsequently determined by the Debtor that due to the current financial situation, the best course of action would be to file the NOI in an attempt to restructure the business and file a proposal to its creditors.
18. The Debtor's assets consist primarily of accounts receivable with a gross book value of approximately \$1.3 million, as well as inventory (mainly raw materials) and various fixed assets with a net book value of approximately \$0.4 million and \$1.4 million respectively at the time of the filing.

THE DEBTOR'S CREDITORS

19. At the time of the filing of the NOI, the Debtor's books and records reflected the following amounts due to its creditors:
- a) Secured Creditors:
- The TD Bank - \$0.9 million. Subject to a full security review to be performed, the Proposal Trustee is informed that TD has registered a first ranking charge on all of the Debtor's assets, except for the existing equipment under capital leases;
 - Parties who have published ownership retention interests with respect to equipment.
- b) Unsecured Creditors:
- The Debtor's books and records reflect an amount of approximately \$2.4 million consisting of the following:
 - Trade creditors: approximately \$2 million;
 - Related party: approximately \$0.3 million;
 - Employees: approximately \$0.1 million in respect of accrued vacation pay.

OBJECTIVES OF THE DEBTOR'S NOI PROCEEDINGS AND EFFORTS TO STABILIZE THE BUSINESS OPERATIONS

20. As noted above, as a result of a number of factors, the Debtor has suffered significant losses in the past two years and has overhead costs that greatly exceed the production levels required by the Company. In the circumstances, the Debtor has determined that it is in the best interests of all stakeholders for the Debtor to commence this NOI process as well as the SSP (as defined below) to determine if the business can continue on a going-concern basis or if it will be liquidated for the benefit of its stakeholders.
21. Since the filing of the NOI, the Debtor, has been focused on a number of areas to stabilize the business and preserve its going concern value.
22. These efforts include, but are not limited to:
 - a) Communications and making arrangements with major suppliers to ensure continued supply of product to enable the Company to fulfill existing and future orders;
 - b) Communications with the Company's employees to explain the process and to ensure their full cooperation during the filing period; and
 - c) Seeking additional funding through the DIP financing to permit the Company sufficient time to run a going concern sale process.

DIP FINANCING

23. While the TD Bank is willing to provide ongoing funding pursuant to the existing credit facility (with certain modifications), the short-term cash flows of the Debtor (as summarized below) demonstrate a need for additional financing. As a result, the Debtor has signed a commitment letter with one of its minority shareholders JGALA Holdings Inc. / Placements JGALA Inc. (the "**Interim Lender**") to provide additional funding to the Debtor subject to various terms and conditions, including:
 - a) A maximum facility amount of \$600,000;
 - b) Interest at the rate of 18% per annum;
 - c) A facility fee of \$10,000; and
 - d) A charge on the assets of the Debtor which will rank after the TD Bank and the Administration Charge (as described below).
24. The commitment letter contains various standard terms and conditions relating to repayment, reporting requirements, covenants and terms of default. The repayment clause sets a repayment

date of March 15, 2019 by which all advances from the Interim Lender must be repaid unless a later date is agreed to by the Interim Lender.

ADMINISTRATION CHARGE

25. The DIP, SSP and Extension Motion calls for an Administration Charge in the amount of \$100,000 to secure the post-filing professional fees of the Proposal Trustee, the Proposal Trustee's counsel, and counsel for the Debtor. The Trustee and Debtor's counsel have each received a pre-filing retainer of \$25,000 which will be applied to the final outstanding invoices.
26. The Administration Charge will rank after the security of the TD Bank and prior to the DIP financing charge.

SALE AND SOLICITATION PROCESS

27. The Company with the assistance of the Proposal Trustee will commence a sale and solicitation process (the "**SSP**") to sell the Company or its assets with the intention of continuing the business on a going-concern basis, if possible. The following is a brief timeline that is expected to govern the SSP, assuming approval by the Court:
 - a) **February 1, 2019:** Issuance of a teaser document to potential interested parties including strategic buyers, financial investors and liquidators;
 - b) **February 1, 2019:** Opening of a digital data room (to be maintained by the Proposal Trustee) which will contain the relevant necessary information to enable interested parties to evaluate all aspects of the Company's business including financial statements, sales by customer (with certain confidential information removed), details of existing receivables, inventory and equipment, copies of leases, as well as the terms and conditions of sale;
 - c) **February 2 to February 24, 2019:** Due diligence period for interested parties. All parties who wish to gain access to the data room will be required to first sign a non-disclosure agreement;
 - d) **February 25, 2019:** The deadline to submit offers to the Proposal Trustee will be Monday February 25, 2019 at noon Montreal time. The offers will be opened by the Proposal Trustee immediately thereafter;
 - e) **February 27, 2019:** The deadline for offers to be accepted or rejected will be Wednesday February 27, 2019 at 5:00 PM Montreal time.
 - f) **March 1, 2019:** Selection and execution of a definitive agreement (or agreements) based on the offers received through the SSP;

g) **March 8, 2019:** Approval by the Court and closing of the contemplated transaction.

The above noted timeline is subject to change by the Debtor with the approval of the Proposal Trustee.

THE DEBTOR'S CASH FLOW FORECAST

28. As noted above and annexed as Exhibit C are the Projections of the Debtor which cover the first thirty-two days following the filing of the NOI.
29. In support of the extension sought, the Debtor has prepared a statement of projected cash flow (**Exhibit "D"**) covering the period January 21, 2019 through March 15, 2019 which we summarize as follows:

30. The statement of projected cash flow was prepared on the basis of continuing operations and takes into account the Interim Financing.

REQUEST TO EXTEND THE PROPOSAL PERIOD TO MARCH 13, 2019

31. The Debtor is requesting the extension of the Proposal Period to March 13, 2019 (the "Extension").
32. The Proposal Trustee supports the Debtor's request for the Extension for the following reasons:
 - a) The Debtor requires this time to proceed with the implementation of the SSP;
 - b) the Debtor is acting in good faith and with due diligence in taking steps to maximize the value of its assets for the benefit of its creditors;
 - c) it is the Proposal Trustee's view that the Extension will not prejudice or adversely affect any group of creditors; and
 - d) the TD Bank has been advised of the Extension and does not oppose the Extension sought herein.
33. While it is too early to determine whether a viable proposal will be presented by the Debtor to its creditors, in the Proposal Trustee's view, the Debtor's request for the Extension is appropriate in the circumstances.

CONCLUSION AND RECOMMENDATION

34. Based on all of the forgoing, the Proposal Trustee respectfully recommends that this Honourable Court grant the relief sought in the DIP, SSP and Extension Motion, as summarized in paragraph 6(g) of this First Report.




