MAY 31, 2020

I. INTRODUCTION

- On March 18, 2020 (the "Appointment Date"), pursuant to an order (the "Receivership Order") of the Court of Queen's Bench (Winnipeg Centre) (the "Manitoba Court") made in Court File No. CI 20-01-26627 (the "Canadian Proceedings"), Richter Advisory Group Inc. ("Richter") was appointed as receiver (in such capacity, the "Receiver") of the assets, undertakings and properties (the "Property") of Nygård Holdings (USA) Limited, Nygard Inc., Fashion Ventures, Inc., Nygard NY Retail, LLC (collectively, the "US Debtors"), Nygard Enterprises Ltd. ("NEL"), Nygard International Partnership ("NIP"), Nygard Properties Ltd. ("NPL"), 4093879 Canada Ltd., and 4093887 Canada Ltd. (collectively, the "Canadian Debtors") (the US Debtors and the Canadian Debtors together, the "Nygard Group" or the "Debtors") to exercise the powers and duties set out in the Receivership Order, pursuant to section 243(1) of the Bankruptcy and Insolvency Act, R.S.C. 1985, c. B-3, (the "BIA") and section 55 of The Court of Queen's Bench Act, C.C.S.M. c.C280.
- 2. The Receivership Order was granted pursuant to an application made by White Oak Commercial Finance, LLC, as administrative agent and collateral agent for and on behalf of White Oak and Second Avenue Capital Partners, LLC collectively, the "Lenders") pursuant to security held by the Lenders in the Property of the Debtors provided in connection with a certain loan transaction and a revolving credit facility (the "Credit Facility") provided thereunder.
- 3. Also on March 18, 2020, the Receiver, as the duly appointed foreign representative of the Debtors, commenced proceedings in the United States Bankruptcy Court for the Southern District of New York (the "US Court") by filing, among other things, petitions (the "Chapter 15 Petitions") on behalf of the Receiver in relation to the Debtors pursuant to sections 1504 and 1515 of the US Bankruptcy Code seeking recognition by the US Court of the Canadian proceedings as a foreign main proceeding (the "Chapter 15 Proceedings"). On March 26, 2020, the US Court entered, among other things, a provisional recognition order and, on April 23, 2020, the US Court granted a final order (the "Final US Order") recognizing, among other things, the Canadian Proceedings as the foreign main proceeding. The Canadian Proceedings and the Chapter 15 Proceedings are together hereinafter referred to as the "Receivership Proceedings".
- 4. On April 29, 2020, the Manitoba Court made various Orders, including an Order (the "Sale Approval Order") which, among other things, approved an agreement (the "Consulting and Marketing Services Agreement") between the Receiver and a contractual joint venture comprised of Merchant Retail Solutions, ULC, Hilco Merchant Resources, LLC, Hilco IP Services, LLP dba Hilco Streambank, and Hilco Receivables, LLC (collectively, "Hilco" or the "Consultant"), and White Oak Commercial Finance, LLC pursuant to which, the Consultant will provide certain consulting, marketing and related asset disposition services. In addition, as it appeared that a going concern or "enbloc" sale of the Nygard Group's assets was not likely, the Sale Approval Order authorized the Receiver to liquidate

the Nygard Group's retail inventory and owned furniture, fixtures and equipment ("FF&E") through temporarily reopened stores (the "Liquidation Sale"), as soon as circumstances permit. As certain details regarding the
Liquidation Sale of particular importance to landlords of the Nygard Group's retail stores (the "Landlords") were not
capable of being known with any precision or certainty at the time (given COVID-19 restrictions on non-essential
business activities), the Sale Approval Order set out a process that required the Receiver to obtain a further order of
the Manitoba Court addressing certain specified matters prior to commencement of the Liquidation Sale.

- On April 29, 2020, the Manitoba Court also pronounced two (2) further Orders: (i) an Order (the "General Order") addressing, among other things, various general matters, including certain amendments to the Receivership Order and the procedure for landlord access to properties leased to the Nygard Group by certain non-Debtor members of the Nygard organization, and (ii) an Order (the "Documents and Electronic Access Order", and together with the General Order and the Sale Approval Order, the "April 29 Orders") establishing the protocol for requesting access to and / or production of documents and electronic files purported to be in the possession or control (or subject to the possession or control) of the Receiver by certain non-Debtor members of the Nygard organization or directors, officers and employees of the Nygard Group. The status of the April 29 Orders is addressed later in this report.
- 6. In accordance with the Receivership Order, the Receiver has established a website (the "Receiver's Website") for the purposes of these proceedings at https://www.richter.ca/insolvencycase/nygard-group.
- 7. Copies of the pleadings and other materials filed in the Receivership Proceedings, other than affidavits sealed by Order of the Manitoba Court, are posted to and available for review at the Receiver's Website.
- 8. Copies of the pleadings and other materials filed in the Chapter 15 Proceedings are also posted to and available for review at the Receiver's Website.
- 9. The Receiver has engaged Thompson Dorfman Sweatman LLP (Winnipeg) ("**TDS**") as its Canadian counsel, and Katten Muchin Rosenman LLP (New York) ("**Katten**") as its U.S. counsel.

II. PURPOSE OF REPORT

- 10. On May 27, 2020, the Receiver filed its second report (the "**Second Report**') in support of the Receiver's motion (the "**June 1 motion**") returnable June 1, 2020 for, among other things, an Order from the Manitoba Court addressing Landlord matters in relation to the conduct of the Liquidation Sale (the "**Landlord Terms Order**").
- 11. This report (the "Supplementary Second Report") is filed by the Receiver to respond to certain matters raised by counsel to the Nygard Group, Levene Tadman Golub Law Corporation, in its Brief dated May 31, 2020 (the "Brief") filed in response to the Second Report and the June 1 Motion.

III. TERMS OF REFERENCE

- 12. In preparing this Supplementary Second Report, the Receiver has relied upon information and documents prepared by the Debtors and their advisors, including unaudited, draft and/or internal financial information, the Debtors' books and records, discussions with representatives of the Debtors, including current and former employees, executives and / or directors, legal counsel to Mr. Peter Nygard and certain related but non-Debtor entities, the Lenders and their legal counsel, and information from third-party sources (collectively, the "Information"). In accordance with industry practice, except as otherwise described in the Supplementary Second Report, Richter has reviewed the Information for reasonableness, internal consistency, and use in the context in which it was provided. However, Richter has not audited or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would comply with Generally Accepted Auditing Standards ("GAAS") pursuant to the Chartered Professional Accountant of Canada Handbook and, as such, Richter expresses no opinion or other form of assurance contemplated under GAAS in respect of the Information.
- 13. The Receiver has prepared this Supplementary Second Report in its capacity as a Court-appointed officer to support the relief being sought by the Receiver at the June 1 Motion. Parties using this Supplementary Second Report, other than for the purposes outlined herein, are cautioned that it may not be appropriate for their purposes, and consequently should not be used for any other purpose.
- 14. Capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Receivership Order.
- 15. Unless otherwise noted, all monetary amounts contained in this Supplementary Second Report are expressed in Canadian dollars.

IV. OBLIGATIONS OF NYGARD PROPERTIES LTD.

- 16. In the Brief, the Nygard Group asserts that the conditional agreements of purchase and sale on each of the Toronto Property, the Inkster Property and the Notre Dame properties could satisfy NPL's limited guarantee obligations to the Lenders, thus permitting NPL to continue with its BIA proposal process. While the Credit Agreement describes the limit of the Lenders' recourse to proceeds from the realization of NPL assets to US\$20 million after costs and expenses, the Credit Agreement does not limit the availability of additional proceeds realized by the Receiver on assets of NPL for the payment of claims of other creditors of NPL.
- 17. Based on the Information reviewed to date, the Receiver understands NPL could have unsecured obligations owing to other members of the Nygard Group as well as third-party creditors.
- 18. The Receiver notes that Schedule 7.03 of the Credit Agreement outlines all of the intercompany arrangements of the Nygard Group as at December 30, 2019, a copy of which is attached hereto as **Appendix "A"**. As detailed in

Appendix A, NIP was owed \$18,206,000 and \$2,872,000 from NEL and NPL, respectively, as at December 30, 2019. The Receiver understands these intercompany amounts are generally consistent with the NIP's unaudited internal financial statements for fiscal 2019 dated February 1, 2020. As of the date of this Supplementary Second Report, the Receiver has not had an opportunity to reconcile the intercompany balances of the Debtors.


- 19. The Receiver also notes that on March 9, 2020, each of the Canadian Debtors commenced proposal proceedings by filing with the Office of the Superintendent of Bankruptcy (the "OSB") Notices of Intention to Make a Proposal ("NOI") under the BIA in Ontario, for the purpose of staying the exercise of remedies of creditors of the Nygard Group and otherwise accessing the proposal provisions of the BIA.
- 20. A copy of the NOI e-filed with the OSB on behalf of NPL was obtained by Richter on or about March 10, 2020, a copy of which is attached hereto as **Appendix "B"**. As detailed in Appendix "B", NPL lists third-party creditor claims totaling approximately \$25.1 million, which listing does not include the amounts owed to the Lenders. The Receiver notes that the NOI included in Appendix B was transmitted to the OSB through its E-Filing Service and therefore did not contain any signatures. As of the date of this Supplementary Second Report, the Receiver has not had an opportunity to review the books and records of NPL in order to verify the creditor claims listed in the NOI.


