On September 8, 2021, at the meeting of creditors, convened pursuant to Section 102(1) of the BIA, Richter Advisory Group Inc. (the "Trustee") was duly appointed as Trustee, unanimously confirmed by the creditors in attendance.

Note 2: On September 24, 2021, the Trustee received one offer of \$2,000 from a liquidator for all the Company's assets for sale including the trademark. The Inspector authorize the Trustee to accept the Offer.


