WHAT IS A COOKIE?

Cookies are small text files sent by a website server and stored on a web browser so that they can be accessed later from that browser. They are saved in the browser directory (on your hard drive or other local storage media) and stored in RAM while the browser is running.

2. WHAT ARE COOKIES USED FOR?

We use cookies to learn more about your interaction with our content, assist us in our promotional efforts and help us improve your experience when you visit our website. For example, some cookies memorize your preferences so you don't have to repeat your choices when you visit our website. To obtain visitor statistics, Richter also uses analytics tools to collect simple data such as domains, the time of day material is viewed and the types of browsers used to access our website. These tools use cookies to help collect this information. Please note that we may collect analytical data directly or use external analytics tools and services. Where possible, we collect and use this data in aggregate form so that it cannot be reasonably manipulated to identify a particular user within the group.

3. HOW CAN YOU MANAGE THE USE OF COOKIES?

You can control your cookie preferences through our cookie settings, available at https://www.richter.ca/

Through your browser

You can change your preferences for our website and/or the websites of any third-party provider by changing your browser settings. You can also delete cookies at any time. Please note that most browsers automatically accept cookies. If you don't want cookies to be used, you may therefore have to delete or block cookies yourself.

If you reject the use of cookies, you can still visit our website, but some features may not work properly. You can also visit www.allaboutcookies.org for more details on how to delete or reject cookies and for more information on cookies in general.

4. THIRD-PARTY COOKIES AND ANALYSES

4.1 Duration of cookies

- Temporary cookies (also known as "session cookies"): Temporary cookies are intended to remain in your browser only during your browsing session, i.e., until you close your browser.
- Persistent cookies: Persistent cookies remain in your browser after your browsing session (unless they're deleted).



4. THIRD-PARTY COOKIES AND ANALYSES (CONT'D)

4.2 Source of cookies

- Internal cookies: Internal cookies are cookies issued from the richter.ca domain that are generally used to identify preferences (e.g., language preferences), ensure the basic functionality of the site or support our analytics tools or marketing efforts.
- Third-party cookies: Third-party cookies belong to and are managed by other parties. These cookies may be required for analytics tools or to enable certain ads to be displayed outside the Richter website.

4.3 Functions of cookies

Functionality cookies: Functionality cookies allow the website to remember choices you make (e.g., changes to text size, custom pages) or incorporate services such as blog comments.

Performance cookies: Performance cookies collect information about your use of the website, such as webpages visited and any error messages. These cookies do not collect information to identify an individual. The information collected is assembled in such a way as to remain anonymous. Performance cookies are used to improve the operation of a website.

Advertising or targeting cookies: Advertising or targeting cookies are used to improve advertising. Common applications include targeting ads based on information relevant to the user, as well as improving reporting on ad campaign performance and avoiding showing the user ads they have already seen.
