MOTION TO OBTAIN AN EXTENSION OF THE DELAY TO FILE A PROPOSAL
(Article 50.4(9) of the *Bankruptcy and Insolvency Act*, L.R.C. 1985, c. B-3)

TO ONE OF THE HONORABLE JUDGES OR THE REGISTRAR OF THE SUPERIOR COURT, SITTING IN COMMERCIAL DIVISION, IN AND FOR THE DISTRICT OF MONTRÉAL, THE DEBTOR/PETITIONER SUBMITS THE FOLLOWING:

1. On October 10, 2014, the Debtor/Petitioner filed a notice of intention to make a proposal (the "NOI") pursuant to the provisions of the *Bankruptcy and Insolvency Act* (the "BIA"), the whole as appears from the Court record;
