1, Pursuant to the Order of the Ontario Superior Court of Justice ("Court") dated April 24, 2007, Richter Advisory Group Inc., [formerly RSM Richter Inc.], was appointed as Receiver of AMT International Mining Corporation. Upon completion of its administration, the Receiver remitted its surplus for the benefit of AMT. The Receiver made application to the Ontario Court which gave authorization to the Receiver on September 10, 2013 pursuant to the Discharge Order to have AMT file an Assignment in Bankruptcy with Richter for the benefit of AMT creditors.

Accordingly, AMT International Mining Corporation filed an Assignment in bankruptcy on October 25, 2013, and Richter Advisory Group Inc., was appointed as Trustee of the Estate of the bankrupt by the Official Receiver.
