Dear suppliers and creditors,

On August 12, 2010, the management of Power Battery (Iberville) Ltd (the "Company") decided to file a Notice of Intention to Make a Proposal to its Creditors under the *Bankruptcy and Insolvency Act*. This decision was made in order to allow the Company to proceed with an operational, commercial and financial reorganization while ensuring the continuity of operations. During this process, the plant will remain in operation and will continue to service the Company's clients.

Over the past few years, the Company has suffered a steady decline in revenues, as well as an important increase in the cost of its main raw material, lead. As such, the Company's earnings and operating margins have been insufficient to support its cost structure and level of operating expenses, which resulted in substantial losses and significant cash flow pressure.

It was important to make this decision immediately in order to allow the Company to continue its operations and have as many restructuring options as possible. In attempting to restructure the Company's business as a going concern its creditors will obtain a higher realization than they would through liquidation.

The purpose of the proposed reorganization is to allow the Company to make the necessary changes, to ensure its long-term viability, from both an operational and financial standpoint and in the best interest of all parties, namely its employees, clients, suppliers and others.

We appreciate your support during this difficult time.

RSM Richter Inc. will act as Trustee to the Company under the Notice of Intention to Make a Proposal.


Upon the filing of the contemplated Proposal, a **further** notice shall be mailed to you providing you with the following:



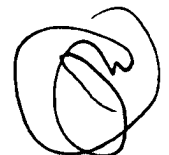

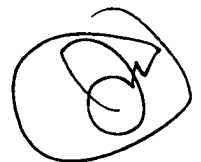
