INSTRUCTION LETTER FOR THE CLAIMS PROCESS OF

A. Claims Process

By order dated November 28, 2011 (the "Order") under the *Companies' Creditors Arrangement Act*, R.S.C. 1985 c. C-36, as amended (the "CCAA"), the Petitioner has been authorized to conduct a claims process (the "Claims Process").

This letter provides instructions for completing the proof of claim. For your information, there is currently no proposed plan under the CCAA. Capitalized terms which are not otherwise defined herein shall have the meaning ascribed thereto in the Order.

The Claims Process includes any person having a claim of any kind, except for an Excluded Claim, against the Petitioner, relating to any obligation arising of existing facts as of August 30, 2011, whether undetermined, contingent or other, and any claim after August 30, 2011 arising out of the restructuring, the disclaimer or resiliation of a contract, lease, employment agreement or other agreement ("Restructuring Claim"), as defined in the Order.

B. Submitting a Proof of Claim
