**ORDER SUSTAINING TRUSTEE'S FIRST OMNIBUS OBJECTION TO  
CERTAIN PROOFS OF CLAIM ON THE BASIS THAT SUCH CLAIMS  
(A) ARE DUPLICATIVE OF OTHER CLAIMS, (B) WERE NOT TIMELY  
FILED, (C) OTHERWISE DO NOT COMPLY WITH THE APPLICABLE  
RULES OR ORDERS OF THIS COURT, OR (D) WERE RELEASED  
OR MOOTED PURSUANT TO THE CONFIRMATION ORDER**

This matter having come before the Court on the *First Omnibus Objection to Certain Proofs of Claim on the Basis that Such Claims (A) Are Duplicative of Other Claims, (B) Were Not Timely Filed, (C) Otherwise Do Not Comply with the Applicable Rules or Orders of This Court, or (D) Were Released or Mooted Pursuant to the Confirmation Order* (the "First Omnibus Claims Objection")<sup>1</sup> filed by Robert J. Keach, the chapter 11 trustee (the "Trustee") of Montreal Maine & Atlantic Railway, Ltd. (the "Debtor"), and after proper notice to all creditors and other parties-in-interest, the Court having independently reviewed the First Omnibus Claims Objection, it is hereby **ORDERED**, **ADJUDGED**, and **DECREED** as follows:

1. The First Omnibus Claims Objection is sustained.
2. The Disputed Claims reflected on Schedules A through D hereto are disallowed in their entirety and shall be expunged from the Debtor's claims register.

3. The Surviving Claim identified on Schedule A will remain on the Debtor's claims register, and such claim is neither allowed nor disallowed at this time, subject, however, to any future objection on any basis.

4. The terms and conditions of this Order shall be immediately effective and enforceable upon entry of the Order.

5. This Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
