APPLICATION FOR THE APPROVAL OF A PROPOSAL
(Section 58 of the *Bankruptcy and Insolvency Act*)

**TO ONE OF THE JUDGES OF THE SUPERIOR COURT, SITTING IN THE
COMMERCIAL DIVISION FOR THE DISTRICT OF MONTRÉAL, OR TO THE
REGISTRAR, THE DEBTOR SUBMITS THE FOLLOWING:**

1. By way of the present application, the Debtor is seeking the approval of a proposal that was filed with the Official Receiver on February 18, 2016 (the "**Proposal**"). A copy of the Proposal is attached hereto as **Exhibit R-1** to form part hereof.
2. All capitalized terms that are not otherwise defined herein shall have the meaning ascribed thereto in the Proposal.
3. The Debtor has been in bottle decoration business since 1961. Due to, among other things, unforeseen sales decline, the Debtor had to restructure its operations and solicit potential investors.
4. On March 7, 2016, a *Notice of Proposal to Creditors and Notice of Hearing of Application for Court Approval of Proposal* was sent by regular mail to the Debtor and to each known creditor to advise of the filing of the Proposal, to call a meeting of the creditors on March 18, 2016 at 9 a.m., and in the event the

Proposal is accepted by the creditors, to schedule the hearing of the present application on April 11, 2016 at 8:45 a.m.


5. On March 18, 2016, the meeting of creditors was held and the creditors voted unanimously to accept the Proposal.
6. The Proposal provides, among other things, for:
 - (a) payment in full of the Employee Claims, Crown Claims and of the Preferred Claims;
 - (b) payment in full for each of the Ordinary Unsecured Creditors having a Proven Claim of less than \$500, without interest or penalty; and
 - (c) a minimum payment of \$500 for the Ordinary Unsecured Creditors having a Proven Claim of at least \$500 plus its pro-rata share of any amount remaining.
7. The Proposal is not addressed to the Secured Creditors.
8. The Proposal is conditional upon the acceptance by its creditors and the approval by the Court of a proposal filed by Serico-Impro Inc., a corporation related to the Debtor and operating at the same premises. Such proposal has been accepted by its creditors and is submitted for approval by the Court concurrently with the present application.
9. On March 31, 2016, the Trustee completed its report on the Proposal and filed a copy of same with the Official Receiver, the whole are more fully appears from a copy of such report together with its proof of filing communicated herewith as **Exhibit R-2** to form part hereof.
10. In its report, the Trustee states that the Proposal is an advantageous one for the Ordinary Unsecured Creditors and represents a better alternative than a bankruptcy scenario. Therefore, the terms of the Proposal are reasonable and will benefit the general body of the Debtor's creditors.

11. During its restructuring efforts, the Debtor received a letter of intent (“LOI”) from a group of investors. The transaction contemplated in the LOI is conditional to the acceptance of the Proposal by the creditors and to its approval by the Court.
12. Considering the foregoing, in order to allow the Debtor to complete its restructuring by closing the transaction contemplated in the LOI, the order approving the Proposal should be enforceable notwithstanding any appeal. The result of the vote on the Proposal also justifies that such a conclusion be granted.

WHEREFORE, MAY IT PLEASE THE COURT TO:

- [A]** GRANT the present *Application for the Approval of a Proposal*;
- [B]** APPROVE the proposal of the Debtor, Plastic Decorators Inc., filed on February 18, 2016 (Exhibit R-1);
- [C]** ORDER the provisional execution of the order to be rendered herein notwithstanding any appeal and without the need to provide security;
- [D]** THE WHOLE, without legal costs, save in the case of contestation.
