**First Interim Report of the Receiver on the Financial Affairs of the Debtor  
(Subsection 246(2) of the *Bankruptcy and Insolvency Act*)**

1. Pursuant to an Order rendered on February 26, 2015 by Maître Chantal Flamand of the Québec Superior Court (Commercial Division) (the "Order"), Richter Advisory Group Inc. ("Richter") was appointed to act as receiver (the "Receiver") for the Assets Purchased from Romatec Inc. ("Debtor") until one of the following events occurs: (i) the sale of all the Assets Purchased; or (ii) any order of the Court ending the mandate of the Receiver.

2. In its capacity as Receiver to the assets of Romatec Inc., Richter hereby reports the following.

**I. Overview**

3. On February 26, 2015, Richter became the receiver in respect of the property of Romatec Inc. described below:

Accounts receivable	\$382,605
Prepaid	\$63,000
Inventory	\$549,008
Capital assets	\$141,332

4. Upon the appointment of Richter as Receiver, all assets of the Debtor were sold to a third party and accordingly, a Vesting Order was rendered by the Court to approve the sale of Assets Purchased and the distribution of the proceeds of the sale.

5. The Motion for the appointment of a Receiver and Approval of a Vesting Order were filed with the Division Office by fax on February 26, 2015.

6. The undersigned did not take possession or control of the property described above in accordance with paragraph 23 of the Order.

8. The proceeds of the sale of the Assets Purchased were remitted to the Receiver and distributed in conformity with the applicable laws.


