Dear creditor or convertible debenture holder of Therma Blade Inc.,

It is with deep regret that we inform you that the Board of Directors of Therma Blade Inc. unanimously voted and resolved to file a **Notice of Intention to Make a Proposal** (the "NOI") as provided under the Canadian Bankruptcy and Insolvency Act. On April 21st the NOI was filed with the Office of the Superintendent of Bankruptcy of Canada.

As most of you have been made aware by management, the Company has struggled financially over the last six to nine months. The decision not to allow Thermablades in the National Hockey League this season delt a major blow to our business plan. It was a bitter disappointment particularly after the resounding success we had testing Thermablades with NHL players in the fall of 2008. At the end of the day however, the NHL decision negatively combined with the timing of the current economic crisis impacted our ability to commercialize the Elite II model of Thermablades which the Company introduced in June/July of last year and set our business plan back at least one year. We strongly believe that the *Elite II* Thermablade is a great product that should be permitted for use by professional players which would create the vital product endorsement needed to be a commercial success.

As a result of the delay in realizing our business plan the Company has come under intense pressure from the debt load that has accumulated on the balance sheet over the last two years. You have all received a copy of the creditor listing which totals approximately \$14 million. The Company's Board of Directors has worked hard over the last 9 months trying to raise capital to alleviate the balance sheet pressure and provide the necessary cash to continue operations on a vastly scaled back basis. Unfortunately, we have not met with success in these fund raising efforts and for this reason we were obliged to file the NOI to allow time and opportunity to restructure the Company.

Over the next two to three months, together with the Trustee RSM Richter Inc., we will be making best efforts to seek a strategic partner to take the Company forward and enable us to make a proposal to all creditors. It remains the objective of all parties who have contributed to the development of the Thermablade product to see it a successful commercial product that truly revolutionizes Canada's favorite game.


