

Notice of objection to the discharge, setting out the reasons for opposition, must be filed with the registrar, at the Court House, Superior Court of Québec – Hull, 17, Laurier, Gatineau QC J8X 4C1 at least five days before the date of the hearing, and a copy of the notice must be served on us within those five days.

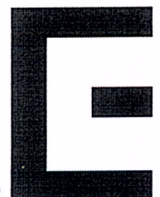




