INSTRUCTION LETTER FOR THE CLAIMS PROCESS OF BOUTIQUE LE PENTAGONE INC. (THE "DEBTOR")

A. Claims Process

By order dated May 10, 2012 (the "Order") under the *Companies' Creditors Arrangement Act*, R.S.C. 1985 c. C-36, as amended (the "CCAA"), the Debtor has been authorized to conduct a claims process (the "Claims Process").

The Claims Process includes any person having a claim of any kind, except for an Excluded Claim, against the Debtor, relating to any obligation arising of existing facts as of <u>April 10, 2012</u>, whether undetermined, contingent or other, and any claim <u>after April 10, 2012</u> arising out of the restructuring, the disclaimer or resiliation of a contract, lease, employment agreement or other agreement ("Restructuring Claim"), as defined in the Order.

B. Submitting a Proof of Claim

If you believe that you have a claim against the Debtor, you will have to file a proof of claim with the Monitor by the Claims Bar Date and/or the Restructuring Claims Bar Date, failing which your claim against the Debtor will be extinguished and forever barred.

The proof of claim must be filed and received by the Monitor by June 22, 2012 at 5:00 p.m., Montréal Time ("Claims Bar Date").

For a Restructuring Claim, the proof of claim must be filed and received by the Monitor no later than the latter of (i) August 17, 2012 at 5:00 p.m., Montréal Time or (ii) thirty (30) days following presumed receipt, for the purposes of Section 12 of the Order, of the Instructions to Creditors ("Restructuring Claims Bar Date").
