Upon the filing of the contemplated Proposal, a **further** notice shall be mailed to you providing you with the following:


- a) A copy of the Proposal;

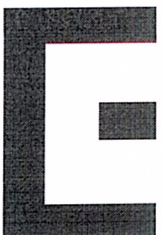
