**Notice and Statement of the Receiver**  
(Subsections 245(1) and 246(1) of the Act)

In the matter of the receivership of  
ExelTech Canada Inc.

The Receiver gives notice and declares that:

**I. INTRODUCTION**

1. On February 4, 2010, ExelTech Canada Inc. ("ExelTech" or the "Debtor") filed a Notice of Intention to Make a Proposal (the "Notice of Intention") in accordance with the Bankruptcy and Insolvency Act (the "Act") and RSM Richter Inc. ("Richter") was appointed as Trustee with respect to the Notice of Intention, as it appears from the documents already filed with the Court. Since then, the delay for the filing of a proposal has been extended by the Court until May 28, 2010, pursuant to Motions filed by the Debtor.
2. On February 9, 2010, pursuant to a Motion filed by the Royal Bank of Canada ("RBC"), ExelTech's secured lender, Richter was appointed Interim Receiver to the assets of ExelTech as it appears from the documents already filed with the Court.
3. On April 29, 2010, the Court granted the Motion filed by RBC Seeking the Appointment of a Receiver and the Authorization to Sell the Property of the Debtor, subject to section 243 of the Act.
4. Prior to the foregoing events, and as set forth below, Richter was appointed as an advisor to the Debtor with concurrence of RBC to conduct a process with a view to identifying strategic investors or purchasers of all or part of the Debtor's business.

**II. SOLICITATION PROCESS**

5. In December 2009, ExelTech hired Richter to initiate and manage a formal process to seek new financing and investment (the "Solicitation Process").
6. Richter communicated with numerous potential investors (over 60), having industry involvement and/or knowledge (according to our research and interviews with management), by sending a document describing the investment opportunity.
7. Richter obtained from a number of parties signed confidentiality agreements which entitled them to have access to the confidential information contained in a data room.
8. On February 24, 2010, Richter advised each of the potential interested parties that ExelTech's Solicitation Process required a definitive and binding offer by March 10, 2010 at 3:00 PM (Eastern Daylight Time), at the latest.

9. After analyzing the offers received on March 10, 2010, it was agreed by the Debtor to request that the offerors consider re-submitting offers by no later than March 16, 2010.
10. On March 16, 2010, a total of eight (8) offers relating to the purchase of the assets of ExelTech and of its parent company ExelTech Aerospace Inc. were received, opened and analyzed in the presence of representatives of the Debtor and the Debtor's legal advisors.
11. On March 29, 2010, after extensive discussions amongst ExelTech, the offerors, the Interim Receiver and the Debtor's legal advisors, ExelTech accepted the offer from Pemco World Air Services Inc. ("Pemco") which represented the best offer. The purchased assets include the inventory of parts and supplies, the tooling and equipment, and other assets owned by ExelTech (the "Purchased Assets") as described below.

12. The purchase price payable by Pemco for the Purchased Assets consists in a cash consideration of \$1,200,000 payable upon closing of the transaction and a contingent additional amount of \$400,000 payable upon certain conditions (i.e. commencement of the commercial activities).

### III. COURT APPROVAL

13. On April 29, 2010, the Court authorized the sale of the Purchased Assets to Pemco by the Receiver.
14. As a result, on April 30, 2010, the transaction was concluded and the cash consideration of \$1,200,000 was remitted by Pemco to the Receiver.

### IV. DISTRIBUTION

15. The proceeds from the sale of the Purchased Assets will be remitted to RBC taking into account claims that may rank ahead of its securities.


