

**Note 1 :** Orbi Construction Group Inc. ("Orbi") filed a Notice of Intention to make a Proposal ("Notice of Intention") under the Bankruptcy and Insolvency Act on October 5, 2011.

Subsequently, on October 28, 2011, Orbi filed an assignment in Bankruptcy under Section 49 of the *Bankruptcy and Insolvency Act* and Richter Advisory Group Inc. (formerly doing business under the name RSM Richter Inc.) ("Richter") was duly appointed Trustee of the Estate.

**Note 2:** Following a sales tender process, the inspectors unanimously authorized the Trustee to accept the offer submitted by Corporate Assets Inc. Offer for the purchase of the Machinery & Equipment, Office Furniture and Computer Equipment.

**Note 3:** HSBC paid directly to Richter an amount of \$5,000 to cover fees.

**Note 4:** On October 4, 2011, pursuant to a motion filed by HSBC Bank Canada ("HSBC"), the primary secured lender, the Quebec Superior Court appointed Richter as Receiver to the assets of Orbi Construction Group Inc. (see Receiver's final statement of receipts and disbursements in Appendix A). With the approval of the secured lender, HSBC, funds were advanced from the Receiver's account to cover priority claims, costs and professional fees.

**Note 5:** Funds were advanced to cover the initial expenses relating to the filing of the Notice of Intention.


