Take notice that:

1. The above-mentioned Debtor filed a Notice of Intention to Make a Proposal on August 12, 2010. A proposal in respect of the aforementioned Debtor, filed on December 3, 2010 under section 62 of the *Bankruptcy and Insolvency Act*, was approved at the First Meeting of Creditors held on December 17, 2010.
2. The proposal was dependent on the success of an investment transaction that was conditional to the restructuring of indebtedness owing to secured creditors. At the hearing of application for Court approval of the proposal on January 20, 2011, the Court refused to approve the proposal and the Debtor was thereupon deemed to have made an assignment. RSM Richter Inc. was appointed as trustee of the estate of the bankrupt by the official receiver, subject to affirmation by the creditors of the trustee's appointment or substitution of another trustee by the creditors.
3. The first meeting of creditors of the bankrupt will be held on February 10, 2011 at 11:00 A.M., at the Office of the Superintendent of Bankruptcy at 5 Place Ville Marie, 8th Floor, Montréal, Quebec.
4. To be entitled to vote at the meeting, a creditor must lodge with the trustee, before the meeting, a proof of claim and, where necessary, a proxy.
5. Enclosed with this notice is a proof of claim form, proxy form, and list of creditors with claims amounting to \$25 or more showing the amounts of their claims.
6. Creditors must prove their claims against the estate of the bankrupt in order to share in any distribution of the proceeds realized from the estate.
7. **It is important to note that, if you have already submitted a Proof of Claim to the Trustee pursuant to the filing of the Proposal, it is not necessary to resubmit your claim, unless the amount is different.**
