The Receiver declares that:

1. On June 9, 2011, we, RSM Richter Inc. ("Richter"), became the Receiver in respect of all the movable and immovable assets (the "Property") of Igloolik Isuma Productions Inc. ("IIP"), an insolvent person, as described below:

- 2. We became Receiver by virtue of an order rendered by Me Chantal Flamand, Registrar of the Quebec Superior Court, (Bankruptcy and Insolvency sector of the Commercial Division) following a Motion for the Appointment of a Receiver to the Assets of IIP, filed by Atuqtuarvik Corporation.
- Furthermore, IIP has filed for bankruptcy on October 26, 2011 and Samson Belair/Deloitte & Touche Inc. has 3. been appointed as Trustee.

4. The Receiver has taken possession of assets located both in Quebec and in Igloolik, Nunavut before the date of bankruptcy. These assets can be summarized as follows:

A. Non Cultural Assets

- 1. Film production and editing equipment and accessories;
- 2. Furniture and general office equipment;
- 3. Building located in Igloolik, Nunavut; and
- 4. Accounts receivable.

B. <u>Cultural Assets</u>

- 5. Library of feature and short films;
- 6. Library of raw footage, outtakes and rushes relating to the Inuit culture and traditions; and
- 7. Costumes and props.
- 5. The Receiver conducted a sale by tender process in October and November 2011. Offers have been received for some of the assets mentioned above. Some of these offers are still subject to conditions that are yet to be lifted.

As soon as the offers are final, the Receiver will apply to Court to get authorization to accept the offers and sell the assets.

- 6. The Receiver's interim statement of receipts and disbursements as at January 30, 2012 is attached hereto as Exhibit "A". The receipts emanate from the collection of the accounts receivable. The disbursements refer to the advertising of the call for tenders in the newspaper as well as all legal fees to obtain a legal opinion on the validity of the securities held by the secured lenders.
- 7. There remain several issues regarding property claims as well as the completion of the sale process. Once all issues will have been resolved the proceeds from the realization if the assets will be remitted to the secured lenders according to their specific rank.
