Notice of objection to the discharge, setting out the reasons for opposition, must be filed with the registrar, at the Court House, Quebec Superior Court – Montréal, 1 Notre-Dame Street E., Room 1.146, Montréal QC H2Y 1B6 at least five days before the date of the hearing, and a copy of the notice must be served on us within those five days.

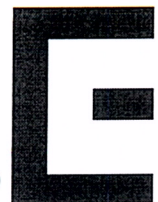


