objection of CP, and this revised form of order having resolved all other informal responses

received by the Trustee; and the Court having found and determined that the relief sought in the

Motion (as restricted in accordance with the prior clause) is in the best interests of the Debtor, its

estate and creditors, and all parties in interest and that the legal and factual bases set forth in the

Motion establish just cause for the relief granted herein; and after due deliberation, and sufficient

cause appearing therefore, it is hereby **ORDERED**, **ADJUDGED**, and **DECREED** that:

1. The Motion is **GRANTED** solely to the extent set forth herein.

2. Pursuant to sections 105 and 554 of the Bankruptcy Code, the Trustee is

authorized to immediately abandon the Selected Pre-2002 Accounting Documents.

3. For the avoidance of doubt, no other relief sought in the Motion is granted (or

denied) at this time. The Trustee's rights to seek such relief at a later date, and all other parties'

rights to oppose such relief, are fully preserved.

4. This Court shall retain jurisdiction to hear and determine all matters arising from

or related to the implementation, interpretation and/or enforcement of this Order.
