- 2. On June 23, 2015, CP filed a Motion to Dismiss the Trustee's Second Amended Complaint. The deadline to file an objection to the Motion to Dismiss is currently July 14, 2015 (the "Objection Deadline"), while a hearing on the motion is scheduled for August 18, 2015.
- 3. By Order dated June 26, 2015 this Court has stayed this proceeding as to all defendants except CP [Adv. D.E. 145].
- 4. CP's counsel has a scheduling conflict with the July 21, 2015 pre-trial conference. Accordingly, CP, with the Trustee's consent, requests that the pre-trial conference be continued from July 21, 2015 to August 18, 2015 at 10:30 a.m. E.S.T., which is the same date and time as the hearing on the Motion to Dismiss.
- 5. Additionally, counsel for CP and the Trustee have agreed to extend the Objection Deadline from July 14, 2015 to July 21, 2015.

WHEREFORE, CP, with the Trustee's consent, requests that the Court enter an Order: (a) continuing the pre-trial conference to August 18, 2015 at 10:30 a.m. E.S.T.; (b) extending the Objection Deadline to July 21, 2015; and (c) granting such other and further relief as may be granted.
