PLEASE TAKE FURTHER NOTICE that adjournment of the Confirmation Hearing will <u>not</u> affect any hearings on other matters previously scheduled for October 5, 2015 at 10:00 a.m. (ET), which will still go forward on that date.

NOTE THAT THE PLAN PROVIDES, AS DOES THE CCAA PLAN, THAT HOLDERS OF DERAILMENT CLAIMS SHALL BE SUBJECT TO RELEASES AND INJUNCTIONS PRECLUDING PURSUIT OF ANY CLAIM AGAINST CERTAIN PARTIES IN ACCORDANCE WITH THE PLAN AND THE CCAA PLAN, AS WELL AS THE CONFIRMATION ORDER, THE CHAPTER 15 RECOGNITION AND ENFORCEMENT ORDER, AND THE CCAA APPROVAL ORDER.
