STATEMENT OF MITCHELL A. TOUPS PURSUANT TO FED.R.BANKR.P. 2019

I, Mitchell A. Toups, Esq., hereby declare as follows:

1. I am a partner of Weller, Green, Toups & Terrell, LLP, (“WGTT”), with a business address of 2615 Calder Avenue, Suite 400 (77702), P.O. Box 350, Beaumont, TX 77704, and I am duly admitted to practice before the courts of the States of Texas and New York. I submit this statement pursuant to Rules 2019(b)(1), (c)(1)(B), (3) and (4) of the Federal Rules of Bankruptcy Procedure. All references to “Rule” in this Statement are references to the Federal Rules of Bankruptcy Procedure unless otherwise indicated.

2. Pursuant to Rule 2019(c)(1)(B), I was retained on behalf of the “Toups Claimants” (as identified on attached Exhibit A) to represent them in the MMA litigation. In that regard, I am counsel to the Law Firms’ clients asserting claims for wrongful death and other damages in this case (the “Toups Claimants”). My representation of the Toups Claimants commenced on or about July 20, 2013.

3. This Court previously ruled that the Wrongful Death Claimants are neither a “group” nor a “committee” for purposes of Rule 2019 (*see*, March 25, 2014 Order appearing at Docket No.790, and associated findings and rulings of the Court on the record as referenced in such Order). Accordingly, the disclosures contained in this Statement only pertain to the Toups


Claimants I represent (wrongful death claimants, business claimants and individual claimants) as “creditors” and my firm as an “entity.”

4. Pursuant to Rule 2019(c)(3)(A), I state that the Toups Claimants are identified on Exhibit A attached hereto. Pursuant to Rule 2019(c)(3)(B), I state that the nature of each disclosable interest of each Toups Claimant is a claim for wrongful death, or other damages arising from the derailment of the Debtor’s train in or about Lac-Megantic, Quebec, on July 6, 2013. The amount of each such claim is set forth on attached Exhibit A.

5. Pursuant to Rule 2019(c)(4), attached as Exhibit B are powers of attorney executed by the Toups Claimants that authorizes the undersigned to act on behalf of the Toups Claimants.
