It is with great regret that we have been forced by circumstances to seek protection under Canadian restructuring laws by filing what is known as a Notice of Intention to File a Proposal. This will give us some time to develop a viable restructuring plan. For the information of our foreign suppliers, this filing is somewhat akin to a Chapter 11 filing in the United States. Its purpose is to provide the company with a hiatus period in which to continue restructuring its affairs as well as to consider devising a proposal acceptable to you for dealing with the existing amounts owed as at the date of the filing.

We have and will continue to communicate with critical suppliers to make arrangements for the ongoing supply of goods and services on payment terms acceptable to you.

Over the past several years we have grown the operations of Polychem into one of the preeminent recyclers of HD in North America. We have become a key supplier to major corporations with ongoing programs both in the pipe and blow mould industries. These programs are required in the building of infrastructure.

This has been achieved through significant investment by our shareholders, hard work by our executive team and a tight focus both on the sourcing of feedstock and the market segments catered to. In particular we have to acknowledge the support and friendship of you our suppliers that have allowed us to obtain the feedstock, transport, packaging, parts, machinery and other services needed to grow.

In the recent past we have experienced the financial equivalent of the “perfect storm” which has brought our working capital from a positive position to a deficiency and challenges our ability to go forward, including having to address the following adverse circumstances (among others):

- the price of mixed color and clear bottles kept rising while resin started to decline. Our customers refused the commensurate price increases as they were aware that resin prices were falling;
- the price of feedstock started a steep decline which wiped out a large portion of our inventory value;
- the value of the US dollar rose significantly as against that of the Canadian dollar, correspondingly increasing our US denominated liabilities and further eroding working capital;
- we have seen large lots of virgin resin being sold at or below our processing costs; and
- we have seen that the low prices being paid to municipal recycling facilities have threatened their ability to separate the streams.

We believe that these factors must at some point correct themselves, and that our industry will recover. Meanwhile, we have instituted a major cost reduction program in the plant.

We are presently unable to service our debts to our valued suppliers and friends. We will, however, work diligently to develop a restructuring plan which will give us the opportunity to succeed and to continue our business relationship with you.

We thank you for your understanding in these very difficult circumstances.
