DISCHARGE ORDER

[1] **CONSIDERING** the Monitor/Petitioner's Motion to discharge RSM Richter Inc. as monitor (the "**Motion**") and the Affidavit of Raymond Massi, sworn December 10, 2010;

[2] **CONSIDERING** the Order of this Court in the present file dated October 20, 2008 (Exhibit P-1) (the "**Sanction Order**"), which approved the Debtor's Second Amended and Restated Plan of Arrangement and Reorganization (the "**Plan**");

[3] **CONSIDERING** the Monitor's Certificate (Exhibit P-2) dated December 10, 2010, filed with the Motion pursuant to paragraph 45 of the Sanction Order;

[4] **CONSIDERING** section 4.7 of the Plan;

[5] **CONSIDERING** the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36;

[6] **FOR THESE REASONS, THE COURT:**

[7] **GRANTS** the Motion to Discharge RSM Richter Inc. as monitor (the "**Motion**");

[8] **DECLARES** that the service of the Motion constitutes good and sufficient service on all persons and further **DECLARES** that the parties are relieved of any other requirements for service of the Motion;


[9] **DECLARES** that any capitalized term not defined herein shall have the meaning ascribed thereto in the Motion;

[10] **DECLARES** the Secured Lenders to be the owners of the sum of \$9,039.62 remaining in the Affected Creditor Fund and **ORDERS** RSM Richter Inc. to distribute it to the Secured Lenders;

[11] **RELIEVES, RELEASES** and **DISCHARGES** RSM Richter Inc. from its appointment as monitor to SRX Post Holdings Inc. under the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36;


[12] **DECLARES** that any provision (included in the law or any order rendered by this Court) relating to the protection or the non-liability of RSM Richter Inc. and its representatives shall survive the discharge;

[13] **THE WHOLE WITHOUT COSTS.**
