Notice of Adjournment of Meeting of Creditors to Consider Proposal (Section 52 of the Bankruptcy and Insolvency Act ("BIA"))

The First Meeting of Creditors held on February 26, 2009 to consider the Proposal filed by Solplast Inc. ("Solplast") was adjourned to March 31, 2009, which meeting was further adjourned to May 15, 2009.

At the continuation of the First Meeting of Creditors held on May 15, 2009, the Trustee advised the creditors that Solplast's operations would **not** continue; that the assets of Solplast would be liquidated, following the sale process; and that in the event of a bankruptcy the unsecured creditors would not receive any dividends.

However, the Trustee further advised the meeting that Solplast's shareholders may be interested in purchasing the Company's tax losses, which may then result in the filing of an amended Proposal by Solplast. The Trustee therefore recommended that the First Meeting of Creditors be further adjourned for approximately sixty (60) days, which adjournment was agreed to by the creditors.

The Trustee has, however, been recently advised that the shareholders are **not** interested in pursuing the purchase of the tax losses. In this regard, we are enclosing herewith a new voting letter as well as a new proxy. The Trustee will disregard the voting letters which it has previously received. Creditors may, however, vote at the July 10, 2009 meeting, either in person or by proxy.

The Trustee is recommending that the creditors vote against the Proposal which will then result in the bankruptcy of Solplast. The Trustee intends to vote its proxies against the Proposal. Immediately upon the occurrence of the deemed bankruptcy, the First Meeting of Creditors under Section 102 of the BIA will be held. The purpose of this meeting is to confirm the appointment of the Trustee and appoint Inspectors (representatives from the creditors) to assist the Trustee in its administration.
