**Notice of Adjournment of First Meeting of Creditors to Consider Proposal**  
(Section 52 of the Bankruptcy and Insolvency Act)

We refer to the Notice of Proposal to creditors which we forwarded to you on February 16, 2009 in respect of a Meeting of Creditors to consider the Proposal which was held at our office on February 26, 2009.

We would inform you that the February 26, 2009 Meeting of Creditors was adjourned to March 31, 2009 at 11:00 a.m. as the Trustee recommended a vote on the Proposal not take place in view of a material change of events. In particular, the Proposal to the creditors had been made on the premise that there would be a substantial infusion of fresh capital to fund the Proposal and operations. On the day before the meeting, the Trustee was advised that the funding would not be available. As of the date of writing, we are not aware of any change in the situation.

Under the present circumstances, we cannot recommend to the creditors that they vote for the Proposal. Accordingly, unless the Trustee is advised before the March 31, 2009 meeting that the funds necessary to satisfy the Proposal will be available, the Trustee will disregard the voting letters which it had received prior to the February 26, 2009 meeting. In this regard, we are enclosing herewith a new voting letter as well as a new proxy form. Creditors may, however, vote at the March 31, 2009 meeting either in person or by proxy.

However, if the Debtor advises the Trustee before the March 31, 2009 meeting that the funds necessary to satisfy the Proposal will be available, the Trustee intends to vote any proxies it receives in favour of the Proposal and to take into account the voting letters received prior to the February 26, 2009 meeting; otherwise, the Trustee intends to vote its proxies against the Proposal.
